SUMMARY:

absence of engagement with Aminiaboko Community rulership/rulership for implementation of the Final Statement Aminiaboko Community versus SPDC & Shell HQ, seven months after its publication by the Dutch NCP; outright REJECTION of the said report by SPDC and SHELL HO following meeting convened by the Honourable Commissioner, Ministry of Environment, Rivers State, Nigeria; Fresh / increasing violations of the OECD guidelines & other infractions and associated issues by SPDC and its contracting companies to the day; the growing insecurity and threats to the lives of Aminigboko Community rulership/leadership cabinet members and their families following the pursuit for justice, among others necessitated our request for PRESS BRIEFING to be facilitated by the Chairman, Nigeria Union of Journalists (NUJ) Rivers State council, Port Harcourt following a letter dated 29th September, 2023 reference number UAP/ACD/08/SEPT2023 to the establishment.
